

## Firewalk Event Terms and Conditions

1. All participants must complete the online entry form and pay the relevant fee due.
2. Children under the age of 12 are unable to participate in the event.
3. Anyone under the age of 18 must be accompanied by an adult.
4. This event is not suitable for wheelchairs or pushchairs.
5. Parents and guardians must agree to accept the disclaimer information for their child before booking. Parents are responsible for their child/children's safety.
6. The booking fee is non-refundable and contributes to the cost of staging the event.
7. We ask that those taking part raise sponsorship in aid of St Margaret's Hospice Care. We ask for a £100 fundraising pledge to be handed in before or at the event. St Margaret's Hospice Care reserves the right to refuse participation in the event if the minimum amount required has not been raised.
8. You agree that all fundraising from sponsorship and donations are given to St Margaret's Hospice Care in full.
9. The event has been organised with safety being paramount.
10. Every walker shall make sure that his/her health is in a condition that allows him/her to take part in the event, and consult a doctor if necessary.
11. Walkers must not be under the influence of alcohol or drugs.
12. All walkers should be well hydrated (drink plenty of water).
13. If you are tired, stressed or recovering from illness you will be less focused and have an increased risk of receiving a blister.
14. Please ensure your feet are clean and free from massage and pedicure oils.
15. No one is forced to walk on fire and we will not allow peer pressure.
16. Participants enter the Firewalk event entirely at their own risk. St Margaret's Hospice Care shall not be liable for any injury or loss occurring as a result of participation in the Firewalk (including, without limitation, any losses resulting from the St Margaret's Hospice Care's negligence), provided that nothing in these terms and conditions shall exclude or limit St Margaret's Hospice Care's liability for death or personal injury resulting from St Margaret's Hospice Care's negligence or for any other type of liability that cannot be excluded or limited by law.
17. Any participants displaying any anti-social behaviour towards participants, volunteers, staff or members of the public will be asked to leave the event immediately.

19. We recommend that you wear casual comfortable clothes. Please remember fires can be quite dirty and clothes may become ash stained. Footwear needs to be easy to remove.
20. Dogs are welcome on a lead at all times and please ensure that you clean up after your dog at all times.
21. Registration for the Firewalk closes at midday on 17 February.
22. If at any point prior to the event you are displaying signs of the coronavirus or you have been diagnosed with it, you must NOT participate in the Firewalk.
23. We hope you'll share your pictures from your event with us on social media. By doing so you are agreeing we can share these and use for promotional purposes.
