

Wingwalk Terms and Conditions

2 April 2022

What do I have to do to take part?

- 1. Complete the online booking form and pay the £100 non-refundable deposit to Wingwalk Buzz.
- 2. Once your registration has been confirmed to us by Wingwalk Buzz, you will be sent a fundraising pack including sponsorship forms and information about online giving, to help you get your sponsorship rolling in.
- 3. You will be required to pay the £499 sponsorship balance to St Margaret's Hospice by Friday 1 April 2022 via an online giving platform (such as Just Giving or Facebook), cash, cheque or card.

How much does St Margaret's benefit from?

1. The minimum sponsorship and your deposit of £599 includes the cost of the wingwalk, which is £399. The remainder is donated to the charity, which means a minimum of £200 will come to St Margaret's plus any additional sponsorship money participants are kind enough to raise will go directly towards the hospice.

Are there any restrictions on who can take part and how fit they should be?

- 1. The minimum age is 18 years and any participants over 65 years old must provide a doctor's signature confirming they are fit to participate.
- 2. The standard upper weight limit is 13 stone 3 pounds / 85 kilos fully clothed.
- 3. All wingwalkers should be in good health and possess a reasonable basic level of fitness. (Certain conditions preclude participants from taking part.)
- 4. Participants mut be able to climb the aircraft to the top wing (approx. 10 feet).
- 5. The principal medical restrictions for all jumpers are diabetes, epilepsy, fits, recurrent blackouts, heart or lung disease, mental illness and some cases of asthma, but if you are in any doubt, please contact Wingwalk Buzz for further information.
- 6. Participants are responsible for ensuring they are medically fit to skydive before signing up to the event and must complete a medical declaration form (form 115A). It may be necessary to consult your GP and ask them to sign and stamp form 115B. All forms can be downloaded from the Wingwalk Buzz website.
- 7. If after reading Form 115A participant is still unsure, then you must seek advice from participant doctor. Wingwalk Buzz staff cannot advise on fitness to jump. Medical concerns raised with SkyDive Buzz staff on the day of participant jump will result in participant being referred to participant doctor to have Form 115B signed and stamped. A rebook fee of £50 will also apply. It is participant responsibility to be truthful on your medical history.

What if I can't raise the minimum sponsorship?





We will provide you with a fundraising pack full of ideas on how to reach your target. You
will also have the support of our Fundraising team to answer any queries along the way.
However, if you do not manage to raise at least £499 prior to Friday 1 April you are able to
make up the shortfall yourself, or transfer to a later challenge, giving yourself longer to
fundraise.

What happens if bad weather effects the jump?

- 1. The event company confirm that in the event of adverse weather the event will be rescheduled for the next available day and time and will liaise with all participants.
- 2. If participants are unable to attend the rearranged time they can move to a separate day when convenient to them.
- 3. In the event of a participant cancelling completely they will forfeit their deposit, and all donations already raised for the charity will be retained.

Am I insured?

- 1. Insurance is provided by Wingwalk Buzz which is covered by the British Skydiving third party Liability Insurance of up to £2 million, at a cost of £18.74 payable at sign up on the booking form and is included in the non-refundable deposit paid by the participant. Please note that this does not cover you or your dependents for personal injury including death.
- 2. All jumpers are strongly recommended to take out their own insurance cover for personal accident benefits to whatever level they consider appropriate. If in any doubt you should seek independent advice.

General notices

- 1. A thorough risk assessment is completed by Wingwalk Buzz and event organisers in advance of the event.
- 2. You must comply with the Covid-19 safety measures put in place at the event.
- 3. No alcohol or illegal substances are to be consumed before or whilst at the event.
- 4. Any participants displaying any anti-social behaviour towards participants, volunteers, staff or members of the public will be asked to leave the event immediately.
- 5. By registering for this event, you are agreeing that any official photographs / videos taken can be used by St Margaret's Hospice Care for any promotional purposes.
- 6. St Margaret's Hospice Care takes its responsibility to protect your privacy and personal data seriously. Our Privacy Notice explains what information we collect about you primarily for fundraising purposes, how we use it, store it, including how long we retain it and with whom and for what purpose we may share it.
