

Santa Abseil Event Terms and Conditions

- 1. All participants must complete the online entry form and pay the relevant fee due.
- 2. Children under the age of 12 are unable to participate in the event.
- 3. Anyone under the age of 18 must be accompanied by a participating adult who are booked in the same wave.
- 4. This event is not suitable for wheelchairs or pushchairs.
- 5. No bookings will be amendable after 1am on Monday 27 November.
- 6. The booking fee is non-refundable and contributes to the cost of staging the event.
- 7. We ask that those taking part raise sponsorship in aid of St Margaret's Hospice Care. We ask for a £125 fundraising pledge to be handed in before or at the event. St Margaret's Hospice Care reserves the right to refuse participation in the event if the minimum amount required has not been raised.
- 8. You agree that all fundraising from sponsorship and donations are given to St Margaret's Hospice Care in full.
- 9. Every abseiler shall make sure that his/her health is in a condition that allows him/her to take part in the event and consult a doctor if necessary.
- 10. On the day there will be transport for participants to the abseil site from the registration site and back after the abseil. Participant supporters (family and friends) will need to make their own way up to the abseil site.
- 11. For safety reasons we ask that participants restrict their supporters (friends and family) to two people on the day, where possible.
- 12. If the abseil cannot go ahead for any reason, St Margaret's Hospice will organise an alternative date with Cave and Climb.
- 13. Participants must not be under the influence of alcohol or drugs.
- 14. The standard upper weight limit is 18 stone, participants cannot exceed 110cm/43 inches around the waist and 65cm/25.5 inches around the thigh for the safety harness to fit correctly. If you require further information please email events@st-margarets-hospice.org.uk
- 15. No one is forced to abseil, and we will not allow peer pressure.
- 16. Participants enter the Santa Abseil event entirely at their own risk. St Margaret's Hospice Care shall not be liable for any injury or loss occurring as a result of participation in the Santa Abseil (including, without limitation, any losses resulting from the St Margaret's Hospice Care's negligence), provided that nothing in these terms and conditions shall exclude or limit St Margaret's Hospice Care's liability for death or personal injury resulting from St Margaret's Hospice Care's negligence or for any other type of liability that cannot be excluded or limited by law.
- 17. Any participants displaying any anti-social behaviour towards participants, volunteers, staff or members of the public will be asked to leave the event immediately.

- 19. Participants must wear sensible footwear and clothing, Cave and Climb reserve the right to refuse participation if sensible footwear and clothing is not worn.
- 20. Registration for the Santa Abseil closes at 1am on Monday 27 November.
- 21. We hope you'll share your pictures from your event with us on social media. By doing so you are agreeing we can share these and use for promotional purposes.
- 22. By registering for this event, you are agreeing that any official photographs taken can be used by St Margaret's Hospice Care for any promotional purposes.
- 23. All participants must attend the safety briefing delivered by Cave and Climb prior to abseiling.
- 24. Participants will be required to tie long hair back and remove all jewellery.
